LETTER FROM THE EXECUTIVE DIRECTOR

This year was truly about being back together again. In the Short North Arts District, we experienced live, in-person events and festivals for the first time since 2019, we saw business patronage unlike anything we have experienced in the last two years, we welcomed dozens of new businesses opening their doors, and watched as existing businesses expanded and reimagined their spaces.

As an organization, we launched new partnerships and services to better support the workforce as it too returned to the Short North Arts District, including a new employment opportunities portal for businesses to support hiring efforts, an innovative new partnership with the Central Ohio Transit Authority called Short North C-Pass, linking over 600 workers with free bus transit services, and a new partnership with Uber for our Short North Employee Mobility Benefits Program, increasing the accessibility of rideshare discounts.

Our community also came together to showcase a commitment to each other. In partnership with the Short North Alliance, our business community created the Short North Good Neighbor Pledge Program, a collaborative, community-wide effort to foster transparent communications among all stakeholders who enjoy the Short North community. Over 100 businesses signed on to take the pledge and many provided resources to support safety in our community. Community well-being was also a top priority for the Short North Alliance in 2022. With support from our private businesses and grants from the City of Columbus, we significantly expanded our Short North Crime Interdiction Program, led a successful social service outreach program pilot with Southeast Healthcare's RREACT (Rapid Response Emergency Addiction and Crisis Team), and partnered with the YWCA Columbus to provide training on belonging and inclusion for members of our business community.

The Short North Arts District continues to be a center of community for so many in Columbus and we are always striving to evolve the programs and services to reflect the needs of our growing community. Because as we grow bigger, we must also grow better.

It is good to be back together again. With convention business growth and even more good things on the horizon, our entire team at the Short North Alliance looks forward to being

together even more in 2023.





AMBASSADOR CLEAN, VISITOR AND SAFE PROGRAMS

The Short North Alliance runs the Short North Ambassador Program, which is staffed by a team of seven full and part time ambassadors who spent over 10,000 hours in 2022 keeping the Short North Arts District clean and safe.

In 2022, the Short North Alliance continued our relationship with Block by Block, one of the country's leading clean and safety service providers for operations of our Ambassador Team.

CLEAN SERVICES

The Short North Arts District is split into 4 zones that help to classify locations of cleaning services and safety incidents so we can better serve the area. The zone boundaries are as follows:

Zone 1: King Avenue to Starr Avenue on High Street (and adjacently served streets)

Zone 2: Starr Avenue to Buttles Avenue on High Street (and adjacently served streets)

Zone 3: Buttles Avenue to Goodale Street on High Street. (and adjacently served streets)

Zone 4: Goodale Street to Convention Center Drive on High Street (and adjacently served streets)

Historically, King Avenue to Starr Avenue has had the highest concentration of cleaning needs.

In 2022, while zones were fairly evenly split, we continued to still see an increase in need in the far Northern end of the District, with lesser need in the far Southern end of the District.



Issues involving late-night violent crime continued in 2022, requiring added programs and resources. The Short North Alliance was successful in securing a \$500,000 public safety grant to address increased violent crime.

SHORT NORTH CRIME INTERDICTION PROGRAM

In 2022, the Short North Alliance continued to oversee the Short North Crime Interdiction Program that was initiated in 2021.

The program was staffed by over a dozen special duty Columbus police officers. This team worked over 3,500 hours and engaged in nearly 700 safety incident interventions. The program ran from March 17, 2022 through November 27, 2022 from 11pm-4am, Thursday through Sunday.

In November, the program was further expanded to add daytime hours on Thursday, Friday, Saturday and Sunday, from 3pm-11pm, for 5 consecutive weeks.

SOUTHEAST RREACT PILOT PROGRAM

Also in 2022, the Short North Alliance established a pilot partnership with Southeast Healthcare's RREACT (Rapid Response Emergency Addiction and Crisis Team) to offer dedicated social workers in our community twice a week to support individuals in crisis.

Over a 60-day period that team made engagements with a total of 115 people resulting in connecting 66 people with direct crisis support services. As of October 1, we expanded the pilot to three days a week and as of December 1, we have entered into a year long partnership to continue having their presence in the neighborhood.

BEAUTIFICATION, **PUBLIC ART** & DISTRICT **IMPROVEMENTS**

In 2022, the Short North Alliance led several beautification and public art projects to enhance the public space and foster creative placemaking in the Short North Arts District.





BEAUTIFICATION

LANDSCAPING PARTNERSHIP WITH BILDSTEN LANDSCAPE SERVICES

The Short North Alliance continued its partnership with Bildsten Landscape Services as its landscape vendor for the District. Trained horticulturists designed and maintained seasonal plantings on High Street, in Poplar Park and Chase Park, along Buttles Avenue, in 18 of the full color planter beds and over 140 of the smaller planter beds installed on High Street.

Additionally, annuals were replanted across the District to replace plant material that has not thrived from the initial High Street Streetscape Improvements Project. We continue to learn what plantings work well in a highly visited area (by both pets and pedestrians).

DELIVER BLACK DREAMS FUNDRAISER

In 2020, as the fight for and support of Black lives filled the streets of Columbus, plywood boards were erected across storefronts. These boards not only served to protect property, but also to offer messages of solidarity and support. Some businesses created artwork themselves and many called upon local artists to help convey these messages. These murals, referred to as the Deliver Black Dreams murals and campaign, were used in different displays throughout the city.

As displays came down and storage of the boards became uncertain, the Short North Alliance stepped in to ensure the preservation of many of these historically important and meaningful works. In collaboration with the Ohio History Connection, some boards were selected, based on condition and significance, to be added to the archives of the National Afro-American Museum and Cultural Center; some boards were donated to the Linden Empowerment Group; and remaining boards were made available for purchase via a fundraiser, which raised \$2,000, to support the Maroon Arts Group.

SUMMER SPRAY

Throughout the summer of 2022, we continued the live mural-making experience in the Short North Arts District called Summer Spray. During this 10-week event, a 1,300-square-foot mural was created outdoors on West Goodale Street, between High Street and Park Street, by 10 local artists. Participating artists also showcased their work in an exhibition space for 10 weeks in the Short North Arts District. The resulting installation remains located on West Goodale Street, between High Street and Park Street. This project was made possible and presented by PNC Bank, with additional support from the Greater Columbus Arts Council, Ohio Arts Council, The Pizzuti Companies and the Short North Alliance Art Fund.



NEW SHORT NORTH C-PASS PROGRAM

Launched in May 2022, individuals who work in and around the Short North Arts District could sign up to receive Free Monthly COTA access to COTA's fixed-route services through the new Short North C-Pass program through the equivalent of a monthly pass (\$62) for all fixed-route COTA bus service. That pass rolled over month to month if they did not use all of the allocated credit within a month until it is used.

The program saw a total of 646 users in 2022 who took over 15,086 in transit rides.

BUSINESS SUPPORT

In addition to safety, clean and parking and mobility support, the Short North Alliance provides a comprehensive roster of services for businesses located within the Short North Special Improvement District's boundaries and those who are Friends of the Short North business members. In 2022, we served over 300 businesses on a daily basis, convened over Small Business Advisory Council, that includes owners of small, local businesses of all types who advise the Short North Alliance's advocacy and planning efforts as they relate to small businesses, offered job fulfillment support; marketing support, including special District promotions; Small Business Resources; and Advocacy and Inclusion Diversity Equity & Access (I.D.E.A.) support.

SHORT NORTH ARTS DISTRICT JOB BOARD

In June 2022, the Short North Alliance launched the Short North Arts District Job Board as a resource for businesses to post employment opportunities. During a year when hiring challenges have faced extremes, this has been a meaningful way for businesses to gain visibility for opportunities and support their continued growth and success. Nearly 50 positions have been offered through the job board in 2022.


SPECIAL PROMOTIONS

In addition to being a megaphone to bring awareness of promotions put on by businesses and organizations in the Short North Arts District, such as Pride, Black Friday, Small Business Saturday, Cyber Monday, the Short North Alliance also creates and executes promotions to promote the economic success of the District.

In 2022, the Short North Alliance continued to offer Short North Arts District Dollars, a universal e-gift card program that can be used at any of the participating businesses in the Short North Arts District.

For the Holiday Season, the Short North Arts District Holiday Trail returned, running from Nov. 18 through Dec. 31. Shoppers who complete the Holiday Trail in 2022 will receive a free \$10 District Dollars E-Gift Card to incentivize continued spending in the Short North Arts District in 2023.

New this year, the Short North Alliance introduced the 12 Days of Deals, featuring 12 days of one-day-only deals from local businesses in categories such as Self Care, For the Art Lover, For the Foodie, For the Home, and more.



ADVOCACY & DEVELOPMENT

ADVOCACY

The Short North Alliance serves as an advocacy voice for businesses and property owners throughout the Short North Arts District. In 2022, we supported the community in numerous ways.

- Led collaborations with community members, the Mayor's Office, City Council, and property owners to initiate the Short North Crime Interdiction Pilot Program, revisions to modifications to scooter restrictions for High Street, and the continuation of the Short North Violence and Injury Prevention Work Group all to address various safety issues.
- Secured \$500,000 in City of Columbus Public Safety Grants to address safety programs and issues in the Short North Arts District.
- Created the Short North Good Neighbor Pledge Program that outlined community standards for private business operations and outlined a transparent communications process to address issues emanating from private business operations and secured \$150,000 in private contributions to support enhanced clean and safe programming.



- Advocated for shared refuse service accommodations for small business.
- Provided support for the renaming of Christopher Columbus Park.
- Advocated for updates to City of Columbus ordinances guiding mobile food vendor operations and noise standards that would support improvements to safety and quality of life for all.
- Advocated for a partnership with the City of Columbus to create Late Night Rideshare pick-up, drop-off zones in unused bus stop locations to support greater pedestrian safety.

DEVELOPMENT

While rates of closures slowed in 2022 when compared to 2021, rates of new businesses opening were comparable to the average from past years. The average number of businesses that open from 2016-2021 in quarters 1-3 is 24. In 2022 through Q3, there were 22 new businesses.

INCLUSION, DIVERSITY, EQUITY, AND ACCESS

Again in 2022, the Short North Alliance led efforts to broaden and deepen inclusion, diversity, equity, and access (I.D.E.A) in both the delivery of programs and services of the Short North Alliance and throughout the Short North Arts District. The council met most months throughout the year and helped to advise the organization on its safety guide, safety plans, Short North CPass Program, outreach programs for individuals experiencing crisis involving housing, addiction, mental health needs, youth intervention programming, and public policies regarding noise and mobile food vending.

Additionally, the Short North Alliance engaged researchers at The Ohio State University's Kirwan Institute for the Study of Race and Ethnicity to provide a more informed community history timeline for display on our website which the better acknowledges the impacts of systemic racism, redlining, and other exclusionary practices that shaped the development of the Short North community.

The Short North Alliance also engaged in organizational restructuring to add a dedicated team member focused on enhancing a more inclusive model of outreach engagement and belonging among the stakeholders we serve.

EVENTS

GALLERY HOP

Also known as Columbus' favorite day of the month to celebrate art, Gallery Hop returned for its 48th year. On May 7, the Short North Alliance partnered with the Columbus Fashion Alliance to introduce the Fashion is Art Gallery Hop, featuring collaborations by artists from local galleries and fashion designers, as well as other special fashion and art related programming throughout the District.

The Short North Alliance continued its nine-year partnership with the Greater Columbus Arts Council's Street Performer Program, which together allowed us to invest \$15,000 to line the streets in the Short North Arts District, with independent performers from around Columbus, as well as some of the city's most respected performing arts institutions. In total, the 2022 Gallery Hop season featured 108 performances and 35 artisan vendors. Additionally, the Short North Alliance received a \$5,000 grant from the City of Columbus Recreation and Parks Department's Special Event Support Program.

SHORT NORTH GALA

The 2022 Short North Gala returned in-person to the Hilton Columbus Downtown. To celebrate the 14th Annual Short North Gala, Short North Alliance hosted a one-of-a-kind evening, featuring performances by DJ Pastel, Scottie G, and Unsung Hero, the Gallery Hop Singer herself, KaTanya Brewer.

Guests enjoyed curated cocktails from Middle West Spirits as well as appetizers and desserts from 'Plas, Ampersand, Del Mar, El Segundo, Parlay, Fireproof, Galla Park, Happy Little Treats, Jeni's Splendid Ice Creams and Insomnia Cookies. We honored an incredible set of honorees who contributed to our local community in so many ways. Honorees in all categories are nominated by the community.
